# Safeguarding Policy & Strategy

This policy applies to all individuals working with or on behalf of Sarah's Star, including employees, volunteers, Trustees, and all levels of staff. It also covers sessional workers, agency staff, students, and any other representatives of the organisation.

# The purpose of our strategy and policy is

- To protect children and young people who receive Sarah's Star services. This includes the children of adults who use our services.
- To provide all staff with the overarching principles that guide our approach to safeguarding and child protection.

Sarah's Star is committed to ensuring that no child or young person experiences any form of abuse. We have a responsibility to promote their welfare and ensure their safety.

Our approach is dedicated to operating in a manner that safeguards and protects all children and young people.

#### **Legal Framework**

This policy has been drawn up based on law and guidance that seeks to protect children, namely:

- GDPR and Data Protection Act 2018

#### We acknowledge that:

- The welfare of the child is the most important consideration, as established by the Children Act 1989.
- Every child, regardless of age, disability, gender, racial background, religious beliefs, sexual orientation, or identity, has the right to equal protection from all forms of harm and abuse.
- Some children may be more vulnerable due to factors such as past experiences, level of dependency, communication needs, or other specific issues.

• Collaborating with children, young people, their parents, carers, and other agencies is crucial to promoting the welfare of young people.

#### **Implementation**

We are committed to keeping children and young people safe by:

- Valuing, listening to, and respecting them.
- Appointing a Designated Safeguarding Officer (DSO), a deputy, and a lead board member responsible for safeguarding.
- Implementing child protection and safeguarding practices through established procedures and a Code of Conduct for staff and volunteers.
- Developing and enforcing an effective e-safety policy and associated procedures.
- Providing strong management for staff, volunteers, and trustees through supervision, support, training, and quality assurance.
- Conducting safe recruitment of staff and volunteers, ensuring all necessary checks are completed.
- Recording and storing information securely, and sharing safeguarding practices with children, their families, staff, and volunteers through leaflets, posters, and direct discussions.
- Using our safeguarding procedures to communicate concerns and share relevant information with appropriate agencies, while involving children, young people, parents, families, and carers when needed.
- Following our procedures to appropriately address any allegations against staff and volunteers.
- Promoting an anti-bullying environment and maintaining policies and procedures to address any bullying that occurs.
- Maintaining effective complaints and whistleblowing processes.
- Ensuring a safe physical environment for children, young people, staff, and volunteers by adhering to health and safety laws and regulatory guidance.

#### Role of Designated Safeguarding Officer (DSO)

Purpose of the role:

Strategic: To take the lead role in ensuring that appropriate arrangements are in place at Sarah's Star for keeping children and young people safe.

Operational: To promote the safety and welfare of children and young people using Sarah's Star services.

- Ensure that all matters related to the safety and welfare of children and young people at Sarah's Star are managed effectively through established policies, procedures, and administrative systems.
- Ensure all staff, volunteers, and Trustees are informed of the procedures and understand their responsibilities if they have concerns about a child.
- Receive and document information from anyone who raises concerns about a child attending Sarah's Star.
- With management support, lead the handling of information that may indicate a child protection concern. This includes evaluating the information, making decisions when needed, and consulting with colleagues, the Chair of Trustees, and statutory child protection agencies.
- Liaise with and exchange information with statutory child protection agencies, including local authority children's social care and the police. This includes making formal referrals when necessary.
- Provide support to staff and volunteers involved in safeguarding matters.
- Consult with the NSPCC Helpline for additional support when needed.
- Be knowledgeable of and adhere to local inter-agency child protection procedures established by the local safeguarding children board.
- Stay informed on issues related to child protection and abuse and keep up to date with new developments in the field.
- Attending relevant safeguarding training periodically and sharing the knowledge gained with staff and Trustees.
